The budget committee met in August and presented the proposed budget for the current Fiscal Year to the board. The budget was unanimously approved and was presented to the members at our first branch meeting on September 17. The budget assumes 80 members which affects both our income as well as our expenses in paying dues to National and New York State. All other expenses basically stayed the same.

In addition, to the membership dues to National we have EOF and LAF contributions that are based on our member numbers. With that in mind we are being asked to raise approximately \$2000 to contribute to the two funds. Based on our current budget we have a shortfall of about \$1100 so additional fundraising and/or contributions is a reality in order to keep our budget balanced. So please support our fundraising activities in this coming year. Every dollar you give helps to provide educational and legal assistance and to improve the lives of millions of women and their families.

As a final note I would like to thank our members who have sent in a donation to help with our newsletter expenses.
