LAF (LEGAL ADVOCACY FUND)

Kurz et al v. Trustees of Indiana University et al. Successfully settled in the fall 2016.

Several national championship-qualifying volleyball team members filed suit against the school who hired a coach with a history of sexually harassing female athletes. The students notified the school of the coach's sexually harassing them but the school refused to protect them. The students claim that when the coach learned of their complaints, he dismissed them from the team. Thus they lost the opportunity to play AND their scholarships jeopardizing their educational futures. At that time there was no Title IX coordinator as required by law, and the school did not advise the students of their rights under Title IX nor did the school intervene to stop either the harassment or the retaliation that followed.

PUBLIC POLICY by Ann Mulligan

Wednesday, March 8 is International Women's Day. On March 8, AAUW will stand in solidarity with the millions of women across the country and around the world committed to advancing gender equality. Whether by observing International Women's Day, participating in the "Day Without a Woman" general strike, or taking action to advance policies that empower women and girls, AAUW members will observe March 8 not as a *day off* but as a "*day on*." Women cannot afford to wait for equality, and it won't happen without our mobilized action.

Did you know.

International Women's Day (March 8) is a global day celebrating the social, economic, cultural and political achievements of women. The day also marks a call to action for accelerating gender parity. This day has been observed since the early 1900's. In 1908 great unrest and critical debate was occurring amongst women. 15,000 women marched through New York City demanding shorter hours, better pay and voting rights. In 1909 in accordance with a declaration by the Socialist Party of America, the first National Woman's Day was observed across the United States. In 1910 at a second International Conference of Working Women, held in Copenhagen, Clara Zetkin (leader of the 'Women's Office' for the Social Democratic Party in Germany) proposed that every year in every country there should be a celebration on the same day - a Women's Day - to press for their demands. The conference of over 100 women from 17 countries, representing unions, socialist parties, working women's clubs, and the first three women elected to the Finnish parliament unanimously approved the proposal and thus International Women's Day was the result.

THE WOMEN'S MARCH ON WASHINGTON, JANUARY 21, 2017

Observations from a grad student at American University, Kathryn Strelevitz (Sylvia Miller's granddaughter.)

"The Women's March in DC was a really incredible experience. There were just so many people! I got there around 11 and was probably 10 - 15 blocks from the main stage. Still, there were so many people that it was at times absolutely impossible to move. As far as you could see in any direction, there were people with signs, hats, and opinions. It was overwhelmingly positive, and I was excited by the spectrum of people and views that were represented. The speakers were great too, though depending on where I was standing, I sometimes couldn't hear them at all.

Since the march, I've had conversations with a couple of people about aspects that were problematic: representation was mostly middle class, educated white women, and the concerns of lower income women of color were not highlighted. People were trying to start the march while speakers were still speaking - and the speakers happened to be women of color. To a degree, from what I can see, that's representative of the women's movement as a whole. In general, white women are aiming to be equal to white men, and the sense is that if a rising tide doesn't lift all boats, issues of women of color will be addressed...later. I don't have very well-formed (or well-informed) thoughts on that subject yet (because on the other hand, we have to start somewhere, a rising tide *can* lift all boats, and there are people working for concerns of communities of color), it has certainly been food for very interesting thoughts.

I protested on Inauguration Day, too. I had intended to watch the speech, but one thing led to another and my friend and I were marching. The contrast between the two experiences was stark. On Friday, the mood was more impassioned, reactionary, and almost desperate. People were more negative and more likely to lash out. There were fewer people, but stronger emotions. Overall, it was harder and more draining. We blocked a highway. My friend went to the Women's March with me too, and he felt that the people in the streets on Friday were going to be in it for the long fight, whereas people at the Women's March were, on the whole, involved more casually. In my view though, we need both groups. The "long fighters" have the fire to keep the issues at the fore; the "casual marchers" have the numbers to make a real impact with any action."
