On March 31, 2020, PowHerNY hosted an hour-long webinar to discuss Pay Equity. AAUW-NYS President, Janice Brown was one of the presenters along with leadership representatives from a variety of other women's advocacy organizations throughout the state.

Equal Pay Day is the symbolic representation of how far into the new year the "typical" women must work in order to earn what the average man earned in the previous year regardless of experience or job type. It was observed on March 31, this year – but if you missed it as you can see from the chart to the left, this date is for "All Women". Women of Color have to work 8 -10 months longer to earn the same pay as their male counterparts doing the same work with the same level of education and experience. So, if you missed it, regrettably you can 'celebrate' again in August and in October.
