PUBLIC POLICY:

PAY EQUITY: The pending New York State salary range disclosure legislation would create a shift in practices, and in culture, to put all workers on more equal footing and to help end the pernicious wage gap that continues to rob some workers, particularly women of color, of fair wages and economic well-being. The bill is through committee in the Assembly awaiting action in the Senate in the Rules and Codes Committees. We are optimistic about getting to the floor for a vote.

CHILD CARE: Empire State Campaign for Child Care and our NYC partners in Campaign for Children are joining forces to push for legislation at the state level that would allow localities to better use their new federal child care funds to expand access to more families; provide stability to child care providers; and take another step toward transforming NY child care. Will you please reach out to your lawmakers (Senator Jim Skoufis, Assemblymember Ken Zebrowski, Senator Elijah Reichlin-Melnick, Assemblymember Mike Lawler by June 12, 2021)

REPRODUCTIVE RIGHTS: Our Reproductive Rights colleagues held two very important issues they wanted to get addressed in this NYS legislature. Those included bodily autonomy through comprehensive sexual education and affordability of abortion services which includes both public and private insurance. Again, please contact your NYS elected leaders to help lay groundwork with Rockland Senate and Assembly elected officials in the NYS 2021 legislative session to encourage them to support, sign-on, and vote in favor.

SEX EDUCATION – Sex education is not mandated in New York state. A study conducted with 2,500 students in K-12 who had participated in a six-week sexual education class showed that these students were less likely to be victims and perpetrators in peer sexual violence, or to be the victims of sexual dating violence. Sex-ed helps prepare young people to not only have safe sex and prevent sexually transmitted infections and unwanted pregnancies, but it also prepares them to have healthier relationships, to make informed choices about whether or when to engage in sex, to understand and practice affirmative consent, to identify abusive behavior, to prevent dating violence, and to gain a strong sense of bodily and emotional autonomy. By failing to fund and require a comprehensive sex-ed curriculum, we are depriving students of the tools they need to live healthier and happier lives. SEXUAL VIOLENCE The Adult Survivor Act would allow survivors of certain sexual offenses, who were eighteen years or older at the time of the offense and who are currently time barred from pursuing civil action, a one-year window to pursue civil action against the person who committed a sexual offense against them or the entity that enabled them.

DOMESTIC VIOLENCE: There is legislation before the Governor to ensure that no matter what may change on the federal level, conversations between DV survivors and advocates will be privileged unless the survivor provides a written, informed consent for release. This legislative package would raise the age of consent for marriage to 18. The bill has passed in the Senate and been sent to the Assembly for further action. PowHer NYS, our AAUW NY Pay Equity colleagues organized an event entitled, "Re-Envisioning How We End Sexual and Intimate Partner Violence". Our host was NYS Attorney General Letitia James. We must continue to provide advocacy and pressure beyond the June (12th) end of session, through campaigns and elections, into the final quarter of 2021, and prepare for the next 2022 legislative session. We must re-commit to grassroots actions with legislators, advocates, friends and family members. We need you to support AAUW's Public Policy priority issues.

The event is free to all and will be conducted online through ZOOM.





THE NATIONAL AAUW 2021 ELECTION RESULTS ARE IN!.....



- Malinda Gaul was re-elected as board vice chair, and Elizabeth Haynes and Joseph Bertolino will also retain their board seats.
 All are three-year terms.
- AAUW's public policy priorities were approved by 92% of voters.
- The ballot initiative to eliminate the membership requirement got 63% of the vote, which was just below the two-thirds majority needed to enact a bylaw change.
