December and winter have arrived! Hunker down, pull out your warm sweats & socks and grab a hot beverage. I have a few things for you to think about... "The American Association of University Women (AAUW) strongly condemns the U.S. Supreme Court's decision in Dobbs v. Jackson Women's Health Organization. The decision overturns the landmark Roe v. Wade ruling that established abortion as a constitutionally protected right nearly 50 years ago and ignores the will of the American people, 80% of whom support legal abortion." (AAUW .org) How is this decision changing our community and way of life? "American women... hold nearly two-thirds of the nation's student-loan debt... President Biden's recent announcement to forgive \$20,000 of student loan debt for Pell Grant recipients, \$10,000 for many other borrowers, and to extend the federal student loan payment pause for all borrowers." (AAUW .org) Will women feel empowered and encouraged to pursue higher education and incur more debt?"In a calculation of the latest data from the U.S. Census Bureau comparing full-time, year-round workers, women took home 83.7% of the pay of men in the same demographic—a figure that is not statistically different from the pay gap in 2020." (AAUW .org) ... While Equal Pay Day for Native American women was November 30th, Equal Pay Day for Latinas is December 8. What advocacy efforts are you/we making to combat this inequality? Please think about the questions above as you consider your participation, and support of AAUW.

This Month's Member Spotlight is on ... Suzanne Belisle



When we sold my mom's house, I 'inherited' all the photos and documents. My job was to organize and digitize photos and documents and distribute originals and copies to family members. My mom had gotten all of *her* mom's documents and photos, since she was the only one who lived locally. As I went over the documents, to my surprise, I discovered that both my grandmothers were born in Maine, but

had citizenship documents. Both my grandfathers were born in Canada. I ended up with three generations of photos and documents for both my maternal and paternal grandmothers. Both my grandfathers died before I was born. I could not figure out why my grandmothers who were both born in Maine had *citizenship* documents, and although I asked older family members, no one seemed to know...

A few years later in 2017, I read an interesting article entitled: "That Time American Women Lost Their Citizenship Because They Married Foreigners." This article provided me with extensive facts and information to pass on to the next generation regarding the puzzling citizen documents of my grandmothers. The author of the article was Tanya Ballard Brown. At the time she wrote this article, she worked for National Public Radio (NPR). I wanted to share the information and republish the article through AAUW, however, NPR refused permission for me to publish the article even after I offered to make a donation to NPR honoring Tanya Ballard Brown. The reason given was that it is because AAUW is an advocacy group and NPR does not want to be associated with any advocacy groups.

Fortunately, we have Wikipedia. Ms. Brown's keywords enabled me to be to conduct more in-depth research. In my family, both my grandmothers were born in the United States but when they married, they became aliens. They could become naturalized citizens only if their husbands applied for, were accepted, and completed the naturalization process. At that time if the marriage was terminated by annulment, divorce or death, repatriation for women was possible by taking various steps. (see Expatriation Act of 1917) It is important to note that an immigrant wife of an American man immediately became a US citizen upon marriage, but an American woman who married a foreigner and

continued to live in the United States lost her citizenship.

The Cable Act was introduced into the House by John L. Cable and passed the House of Representatives on June 20, 1922, passed the Senate on September 9, 1922 and was signed into law by President Harding on September 22, 1922. The Nationality Act of 1940, in effect repealed the first four sections, and amendments of the Cable Act, allowing all women whose citizenship had been lost by marriage to repatriate without regard to their marital status. Fortunately, by providing the names of two key pieces of legislation, Tanya Ballard Brown shed light on an important piece of history that had significant impact on my grandmothers early in their married life. We know that during the First World War, some American women were in danger of being relocated and expatriated if they had married a foreign national.

The hundredth anniversary of the passage of the Cable Law was this year on September 22, 2022. This law determined the trajectory of my family's nationality (on *both* sides) and is responsible for the citizenship that my family will enjoy for generations to come.
